What is toddler allowance?

The toddler allowance is an allowance for every child who is enrolled in a nursery that is recognised by the Flemish Community.

- Toddlers aged 3 years must be enrolled in time.
- Toddlers aged 4 years must be enrolled in time and attend with sufficient frequency.

You receive the toddler allowance:

- For three-year-olds: you receive the toddler allowance in the month following your toddler's third birthday at the earliest;
- For four-year-olds: you receive the toddler allowance in the month following your toddler's fourth birthday at the earliest.

How can you apply for the toddler allowance?

If you already receive the Growth Package, you don't need to do anything. The nursery will send us your child's attendance record and your toddler allowance will be paid automatically as soon as you are entitled to it.

Not receiving the Growth Package because you are not resident in Flanders, but your child is enrolled in a nursery that is recognised by the Flemish Community? Send us the signed and completed application form or submit your application online via <u>kidslife.be</u>

Still have questions related to the toddler allowance? Then please don't hesitate to contact us.

Please notify us if:

- your child has an insufficient attendance record at nursery;
- your child no longer attends a nursery recognised by the Flemish Community.
