What is the study allowance?

Children who are enrolled in a nursery, primary or secondary school in Flanders or Brussels which is recognised by the Flemish Community can, under certain conditions, receive an annual study allowance as part of the Flemish Growth Package. HBO5 Nursing students are also eligible.

Study allowance entitlement is automatically investigated for children living in Flanders. They do not need to complete this application form.

Who needs to apply for the study allowance?

- Students over 25 years of age who are enrolled in an HBO5 Nursing course.
- Students over 25 years of age who are enrolled in special-needs education.
- Pupils who pursue an education at Eureka, Leerwijzer, Safe, Sint-Ignatius.
- Children who pursue an education recognised by the Flemish Community, but who do not live in Flanders and do not receive the Growth Package.

How can you apply for the study allowance?

If you already receive the Growth Package, you don't need to do anything. The educational institution will automatically forward the enrolment details.

If you are not receiving the Growth Package, but your child does attend a nursery, primary or secondary school recognised by the Flemish Community or is pursuing an HBO5 Nursing course, then please send us the signed and completed application form or submit your application online at kidslife.be

Still have questions related to the study allowance? Then please don't hesitate to contact us.

Please notify us if:

- your child no longer attends an educational institution recognised by the Flemish community;
- your family situation has changed;
- your family contains persons older than 25 years of age who are enrolled in higher education (including post Bachelor's or post Master's degree);
- you do not live in Flanders and a family member is recognised as a person with a disability;
- your child is no longer enrolled in boarding school.

The details that you supply on this form are collated to determine your entitlement to the Growth Package and its subsequent payment.
